### Updates from the Division of Licensing and Regulatory Services

The DLRS is committed to creating and sustaining a culture that values and supports continuous quality improvement that is guided and informed by the values of integrity, openness, quality, safety, trust, and validation. Their mission is to hold licensed providers – and themselves – accountable. To do so, they must assure the consistent application of laws and rules for all providers. There is a distinct value for parents to select a licensed child care provider and that value must be honored by effective regulatory oversight.

One recent development is the identification of resources in the Federal Child Care Development Fund Block Grant to add 16 positions in the Children's Licensing and Investigation Unit. This will effectively reduce caseloads from an average of 180 to 80 to align with national standards and allow for the creation of two new supervisory positions. Additionally, the DLRS will convert its practice of surveying licensed providers once per year to a method called differential monitoring. This process guides the use of resources by determining the frequency and/or depth of monitoring based on the provider's level of compliance with regulations.

The DLRS is developing a publically facing web portal for use by parents and guardians to research licensed providers; the portal will provide information regarding the provider's licensure status and a history of any licensing actions, including access to statements of deficiencies and plans of correction related to each licensing action. The goal is to have the portal operational in 2015.

In the past, when conducting investigations of abuse and neglect, the DLRS informed parents and guardians about the complaint alleging abuse or neglect and what to expect during and after the investigation. In the future, the DLRS will also provide information following the investigation to let parents know whether or not there was identified evidence supporting the allegations.

Deficient practices by licensed providers will now be reviewed by a child care licensing advisory panel to determine whether licensing action is appropriate. If so, the panel will advise the recommended action, including license revocation when appropriate. The panel will include relevant licensing personnel, investigators, DLRS management, as well as representation from the Office of the Attorney General.

## New Training! “Environments in Early Care and Education”

This winter Maine Roads to Quality piloted a new 30-hour online training called “Environments in Early Care and Education.” The ten interactive modules cover a wide range of topics with the objective of helping center-based and family child care providers develop a deeper understanding of high-quality environments for children. Every child care setting has its unique benefits and challenges, and through this training participants have opportunities to explore resources, share strategies and ideas, and consider ways to enhance and strengthen the environments in which they work and play with children.

## Maine’s Youth Development Credential: New Cohort Beginning Fall 2014

If you are interested working toward a Youth Development Credential (YDC), including developing competency statements and the portfolio requirements, you are invited to join a cohort of professionals this fall! In order to be part of the cohort, you must have taken at least 60 hours of the trainings required for the YDC, which are:

- *Working with School Age Children and Youth* (30 hours)
- *Links to Learning* (45 hours)
- *Foundations in Health, Wellness, and Safety* (18 hours)
- *Partners in Caring: Families and Caregivers* (12 hours)

## M.S.Ed. in Early Childhood: Applications Available Now!

The University of Maine at Farmington’s Master of Science in Education in Early Childhood degree program:

- Is designed for early childhood professionals who wish to become exceptional leaders.
- Emphasizes child development, curriculum, and assessment of children birth to age 8, as well as an understanding of family and community context.
- Requires 36 graduate credits over a two- or four-year cycle using online and face-to-face classes (approximately 30% face-to-face and 70% online).
- Requires a technologically current computer, up-to-date web browser, and high-speed internet access.

### Caring for Infants, Toddlers, and Their Families (30 hours) – Lewiston

This training covers the unique aspects of providing child care for infants and toddlers in a home or center-based setting.
