# NEW for 2015: Maine's Inclusion Credential and the Revised Inclusive Child Care 30-Hour Training

Maine Roads to Quality has been working in partnership with the University of Maine's Center for Community Inclusion and Disability Studies (CCIDS) on a number of new and revised resources on the topic of inclusion in early childhood.

On **Tuesday, December 16<sup>th</sup> from 1:00 to 2:00pm**, staff from CCIDS will lead a FREE webinar about the new Maine Inclusion Credential. This new credential recognizes enhanced knowledge and skills related to quality inclusive practices. The webinar will outline the competency areas for this new credential, as well as the requirements, including training, and the supports available through MRTQ. #### Supporting Maine's Infants and **Toddlers: Guidelines for Learning and** Development (30 hours) - Online/Hybrid/Faceto-Face



This training is designed to guide providers through the history, creation, and use of this publication, which outlines learning and development from birth to three. The modules focus on orienting providers to the document and on developing understanding relationships.

This training covers topics to fully include and support all children and families in center-based or family child care settings. It uses an interdisciplinary approach to support staff, families and children and emphasizes the beliefs, attitudes, and values of inclusion.

#### Maine's Early Childhood Learning Guidelines (30 hours) - Online



This training is an orientation to Maine's Early Childhood Learning Guidelines that covers integrating the guidelines into your current curriculum, adapting the guidelines to children with special needs, observation and assessment of young children using the guidelines and sharing them with families.

**Dates:** January 7<sup>th</sup> – March 11<sup>th</sup> (no assignments during February vacation)

#### Creating Peace and Honoring Diversity (18 hours) – Hybrid NEW

This training will inspire educators to provide children opportunities to experience the topics of peace and diversity as they start to develop their own selfperceptions in relation to the world around them. Participants will learn how to empower children and families to be proud of who they are, while opening their hearts to those different from themselves.

**Dates:** January 28<sup>th</sup> – February 27<sup>th</sup>; face-to-face classes on Fridays, 2/6 and 2/27; 9:00am-3:30pm; online assignments due between class sessions

**Location:** University of Southern Maine, Portland

#### Linking Assessment to Curriculum in the Preschool Classroom (9 hours) – Online

This training is designed for practitioners working in child care centers to help increase knowledge and level of comfort with the process of assessment and curriculum planning in the preschool classroom.

Dates: February 4th – 25th

#### Teaching Adult Learners (18 hours) - Online

This training is for any professional working with adult learners. It will cover the topics of "who is the adult learner?" self-reflection on who the trainer is as an educator, and the role the trainer plays in present and future professional development of the adult learner. It will also examine the dynamics of online learning and training and explore the requirements for becoming a Maine Roads to Quality Approved Trainer.

Dates: February 4th – March 18th

#### Creating Inclusive Youth Development Settings (30 hours) – Online

This curriculum will take participants through ten modules that provide an overview and foundation of positive youth development practices, strategies and tools for working in school age programs supporting inclusive practices.

Dates: February 4th – April 15th

#### Working with School Age Children and Youth (30 hours) – Online



This training covers the aspects of providing child care for children and youth ages 5 to 13 years in a child care center, family child care program, or before and after school program.

Dates: February 4th – April 15th

#### Caring for Infants, Toddlers, and Their Families (30 hours) – Online



This training covers the unique aspects of providing care for infants and toddlers in a home or center-based setting. Focus will be given to establishing the parent/provider relationship, understanding temperament, curriculum, and setting up and maintaining developmentally appropriate environments.

Dates: February 4th – April 15th

# Foundations of Health, Wellness, and Safety (18 hours) – Hybrid



Participants will be introduced to the importance of health, wellness, and safety through personal care routines, nutrition education, and environmental hazards that could impact the health of children and families.

**Dates:** February 4<sup>th</sup> – March 18<sup>th</sup>; face-to-face classes on Tuesdays 2/10 and 3/10; 6:00-9:00pm; online assignments due between class sessions

Location: Franklin Memorial Hospital, Farmington

# Environments in Early Care and Education (30 hours) – Online

This training covers a wide range of topics with the objective of helping early care and education practitioners develop a deeper understanding of highquality environments for children. Every child care setting has its unique benefits and challenges – through this training participants will have opportunities to explore resources, share strategies and ideas, and consider ways to enhance the environments in which they work and play with children.

Dates: February 4th – April 15th

#### **Please Note:**

- Registration closes two business days before the start of the training to allow MRTQ and the trainer adequate preparation time. Many trainings fill quickly, so we advise you to register early!
- MRTQ is sometimes able to add additional training based on demand; if you try to register for a training that is full, we highly recommend that you place your name on the waiting list. If a second session is added, those on the waiting list receive priority registration!

#### Fostering the Social Emotional Development of Young Children (30 hours) – Hybrid

This training focuses on helping all children develop social skills, self-confidence, and build their socialemotional intelligence. The content covers building relationships, assessing the environment and curriculum, designing strategies to support children to maintain peer relationships, develop skills to improve selfregulation and conflict resolution, and identifying community resources when involving other specialists.

**Dates:** February 7<sup>th</sup> – March 21<sup>st</sup>; face-to-face classes on Saturdays, 2/7, 2/28 and 3/21; 9:00am-3:30pm; online assignments due between class sessions

Location: Maine Discovery Museum, Bangor

#### Partners in Caring: Families and Caregivers (12 hours) – Online



Children experience the best quality of care when parent(s), family, and caregivers are partners with the same goals for the child. This training will offer caregivers information about families today – varieties, characteristics, stresses, challenges, and trends.

Dates: February ||th - March ||th

# Operating a Family Child Care Business (24 hours) – Online

This eight-part curriculum is designed to develop and improve basic business management skills. Learning activities and take-home action steps will encourage participants to practice what they learn to improve their bottom line.

Dates: March 4th – April 29th

#### Stepping Up with *Quality for ME* (12 hours each) – Online

These online trainings are intended to guide programs through the requirements of Maine's quality rating and improvement system, *Quality for ME*. Trainings are available for a variety of settings – family child care, center-based programs, and school age programs. These trainings are designed for programs working to move from a Step I to a Step 2 or from Step 2 to Step 3.

#### Curriculum and Development for Preschool Children (30 hours) – Online/Face-to-Face

This curriculum is designed to introduce participants to planning and implementing curriculum to meet the unique needs of preschoolers. Even though they are all individuals, preschoolers follow a predictable pattern of development. In this training, participants will explore these commonalities and will learn how to make accommodations for children, when necessary.
