

Maine Roads to Quality Professional Development Network (MRTQ PDN) is partnering with the Maine Department of Health and Human Services, Office of Child and Family Services (DHHS, OCFS) to offer Quality Improvement Awards (QIA) to early childhood and out-of school time programs in Maine. Programs that have increased their Step rating with *Quality for ME*, Maine's quality rating and improvement system, are eligible to apply for these awards. The purpose of these awards is to recognize and reward programs for moving from Step 1 to 2 and/or Step 2 to 3 on *Quality for ME*.

Is my program eligible for a Quality Improvement Award (QIA)?

A program is eligible for a Quality Improvement Award (QIA) if:

- The program is enrolled with *Quality for ME*, Maine's quality rating and improvement system and has moved up the Steps:
 - From a Step 1 to a Step 2, or
 - From a Step 2 to a Step 3.
- The Step movement occurs between July 1, 2019-August 31, 2023.
- The program does not have a current conditional license. Upon resolution of Conditional status, the participant may apply for the Quality Improvement Award, if funding is still available.)

What are the QIA amounts?

Moving from a Step 1 to a Step 2 earns a one-time award of \$300.

Moving from a Step 2 to a Step 3 earns a one-time award of \$400.

Could my program be eligible for both awards?

Yes. If your program moves from a Step 1 to a Step 3 between July 1, 2019-August 31, 2023 your program could apply for both one-time awards, for a total of \$700.

Are there requirements for how the QIA can be spent?

No! These funds are awarded as a one-time payment to your program to be used as you choose.

Is there a deadline to apply for a QIA?

QIAs are available between July 1, 2019-August 31, 2023. However, these awards are first-come, first-serve and will be awarded until funds are expended.

How can I apply for a QIA?

If you are designated as the Program Director or Family Child Care Owner at your program, you can log in to your Registry account at <u>https://mrtq-registry.org</u>.

1. If your program is eligible for a QIA, you will see a green notification in the top-right corner of your login page

How and when will I receive my program's QIA?

Upon completion of the application and confirmation of current vendor status, MRTQ PDN will process payment requests. A check will be mailed to the program within 30-45 days. You can check the status of your QIA by contacting Eric Norgaard at <u>eric.norgaard@maine.edu</u> or 207-780-4367.
